TERMS AND CONDITIONS 'ROADIES – ALL ACCESS STAR ("Contest")

Viacom18 Media Private Limited (hereinafter referred to as "Organizer(s)"/
"Viacom18") is the owner and broadcaster of the television program provisionally
titled MTV Roadies ("Program") Roadies All Access Star is a contest being organized
by Viacom18 to find the digital face of the present season of the Program and win
Gratification as more particularly mentioned below in this terms and conditions.

This is a call for entry for content creators and influencers to participate in this Contest. This Contest is open for all Participants (defined below) who comply with the eligibility criteria listed below and the participation shall be governed by the terms and conditions as detailed hereinafter and further Rules (defined hereinafter) determined and intimated from time to time at sole discretion of Viacom18.

1. Eligibility:

This Contest is organized by Viacom18 and is open to all individual participation who comply with below eligibility criteria ("Participants"):

- a. If citizens of India and hold valid proof of citizenship
- b. If foreign national, have all required permissions such as work permits, visas, statutory registration documents, etc. from relevant authorities as may be required to enable them to legally participate in the Contest and/or the Program and their participation shall be subject to 10 (iv) of this Terms and Conditions.
- c. Are above 18 (eighteen) years of age
- d. Are viewers of the Program and Channel MTV India
- e. Have and/or are able to provide a valid email address to Viacom18 when required
- f. Have downloaded the Voot mobile application (owned and operated by Viacom18) on their mobile phone device and/or any other device ("Voot App") and registered themselves on the Voot App
- g. The Participant agrees that he/she will be required to submit all valid proofs of name/ age/ address/ nationality/citizenship, a valid passport, Covid19 double vaccination certificates, test certificates and/or any other document if and as may be required by Viacom18 from time to time and undertakes to provide same when required.
- 2. Contest Participation Period

- i. The Contest shall commence from 10th January 2022 at 11:00 am ("Start Date") and shall be concluded on 17th February 2022, at 23:00 pm ("End Date") or on such date and/or such time as may be determined by Viacom18 in its sole discretion, collectively referred to as ("Contest Period").
- ii. Entries received after the End Date and/or end hours during the Contest Period, if any, as might be intimated by Viacom18 at its sole discretion, shall not be entertained and shall be considered ineligible for the Contest. The End Date/ end hours/ or the Contest Period may be extended and/or modified at the sole discretion of Viacom18 and the same shall be updated on the Voot App or such other modes at the discretion of Viacom18 and/or intimated via such mode, time, date, etc, as may be determined by Viacom18 at its sole discretion and the Participants shall be responsible to keep themselves updated by checking the terms and conditions / any amended terms and conditions with respect to any change /modification made in the terms thereof and any and all such modifications shall apply to all the Participants.

3. Contest Question

Viacom18 will invite participation from the viewers of the Program and desirous Participants, to provide their entry to the contest question explaining i.e 'why you're best suited to be the digital face of India's no.1 Youth Reality Show" i.e the Program ("Contest Question"). The Contest Question might be refreshed/changed and communicated accordingly from time to time to the viewers of the Program during the Contest Period at the sole discretion of Viacom18 and the Contest Video (defined later) shall be strictly in relation to the Contest Question. The Contest Question shall be displayed on the Voot App under the "Roadies – All Access Star Contest" page/ tab and/ or any other page/ tab on the Voot App and/or on television channel(s) of Viacom18 and/or such other medium as may be intimated by Viacom18.

4. Contest Video

- i. Participants will be required to share their entry by recording their response to the Contest Question in the form of an audio-visual recording ("Contest Video") and submit the same on the Voot App in the manner as instructed and detailed on the Voot App, for selection by Viacom18, at its sole discretion to telecast / exhibit the selected Contest Videos either during airing of the Program on the Channel and/or in any other manner on any other platforms, including Voot App or any such other digital platforms as per Viacom18's sole discretion.
- ii. Any recording of the Participant sent as an entry/ video other than as per mentioned in the Contest guidelines/the terms detailed herein and/or in accordance with the specifications on the Voot App may be deemed to be an invalid entry and Viacom18 shall not be responsible or liable for any claims arising therefrom.

iii. The Participant shall ensure that the duration of the Contest Video will be 60 (sixty) seconds. Any Contest Video which does not adhere to the aforesaid duration may be rejected. The Participants may upload his/her Contest Video on the Voot App one time during the Contest Period. If more than one entry is received by Viacom18 from same Participant, Viacom18 at its discretion shall select the Contest Video as the Participant's final / last entry for the purpose of selection and consider any entry thereof.

iv. The contents of the Contest Video shall be, at all times subject to the S&P guidelines as detailed in Annexure A hereto. In the event the Contest Video is not as per the S&P guidelines, the Contest Video shall be deemed disqualified.

5. Method of Participation

In order to participate in the Contest, the Participant will be required to download the Voot App, follow the registration process as displayed therein and submit the Contest Video in the manner as prescribed hereinafter. Participation process shall include the following steps:

- i. The Participant shall be required to click on the link as displayed on the Voot App, in the 'Roadies All Access Star Contest' section and login/complete the registration process by using their social media logins such as Facebook or Google account etc as may be provided there. Basic information of each Participant such as inter alia, i) Name, ii) Age, iii) Address, iv) Nationality, v) email address, vi) online social media accounts, vii) Contact number/ mobile; viii) existing social media account details (vide which the Participant has chosen to log in); (ix) Basic details publicly available on their social media accounts etc. may be made available to Viacom18 due to participation/ registration using their social media logins and after filling in/ providing all the required details, the Participant shall upload / submit the Contest Video as per the instructions, steps and specifications detailed herein and detailed within the Voot App from time to time.
- ii. By submitting the information on the Voot App, through documents, social media links, and/or otherwise, the Participant hereby waives all privacy rights and/or any other rights including but not limited to proprietary rights, copyrights, etc. and/or any privacy expectations that the Participant may have with respect to the use of the information furnished by the Participant in any manner. Viacom18 and/or Producer may use the information for sending out commercial information and/or for other commercial, publicity or promotional purposes and the Participant shall not raise any objection against the same.

- iii. Requirements of the Contest Video:
- The Contest Video should contain an audio-visual recording comprising of their entries on the Contest Question and each Contest Video shall be subject to (c) below.
- Duration of the Contest Video: The Participant shall ensure that the duration of the Contest Video shall be for 60 (sixty) second and any Contest Video exceeding the aforesaid criteria may be rejected at sole discretion of Viacom18.
- Size of the Participation Video: The maximum permitted size of the Contest Video can be 50 MB.
- Technical Specifications: The Contest Video file can be uploaded by the Participant in the following formats: avi, mov, mp4, mpg, mpeg or any other regular video format.

6. Selection of Participants

- i. Each Contest Video shall be adjudged by the jury engaged by the Organizer for this Contest and evaluated basis the quality of the Contest Video and such other requirement as may deemed fit by the jury and the Organizer. From amongst the Participants who have submitted Contest Video in accordance with and subject to compliance of the terms and conditions herein, if shortlisted, they will get one time opportunity to participate in the further rounds of selection/ shortlisting of the Contest as stipulated in this terms and conditions and as may be determined and intimated by Viacom18, subject to further rules, terms and conditions as may be intimated by Viacom18 and/or the Producer.
- ii. Out of the Contest Videos received on the Voot App, each week approximately 5 (five) Contest Videos will be shortlisted to participate in the next round of selection and audition for the Contest finale. This shortlisting will be repeated each week during the Contest Period. During each weekly auditions rounds, shortlisted participants will be given challenges and tasks by the jury of the Contest to be performed by each shortlisted participants online or as may be instructed by the jury and the Organiser from time to time at the time of participation. From each round of auditions, 1 (one) or 2 (two) participants will be shortlisted to participate in the finale round of the Contest tentatively to be conducted at the end of the Contest Period on such date and time as will be announced by the Organiser at its discretion and during such finale round, all shortlisted participants from weekly audition rounds will be required to compete against each other as per the tasks and challenges given by the jury and the Organiser from time to time at the time of participation. All these rounds of selection and audition will be held online, either on closed third party online platforms like Zoom, etc or live on social media platforms, as per creative discretion of the Organiser determined at its sole discretion and each Participant understands the

nature and format of such participation and undertakes to adhered to same at the time of participation.

- iii. The Participant also understands that getting shortlisted in the Contest (including each step of selection/ shortlisting for the Contest as stipulated herein) is only a preliminary step towards Gratification and it shall be the absolute and sole discretion of the Organizers to allow any other participation/ participants other than those participating through this call for entry process/ present shortlisting process/ final participants and based on creative requirements of Viacom18 and Program and the Participant acknowledges this right of Organizer without any dispute or claim.
- iv. In the event that Viacom18 is of the opinion that none of the Contest Videos are eligible to be selected, then Viacom18 may exercise its discretion not to select any Contest Videos and hence there will be no Winner/s.
- v. Viacom18 will have the right to verify the authenticity of each Contest Video uploaded as part of the Contest and the Participants are required to comply with the requests of Viacom18 to verify the authenticity of the content of their Contest Video(s) submitted to Viacom18.
- vi. Viacom18 reserves the right to disqualify any Participant(s) from participating in the Contest without assigning any reason. The decision of Viacom18 in this regard shall be final and binding upon the Participant(s).
- vii. Selection of the Participants for each next round in this Contest will be subject to the following specific terms:
- a) A shortlisted Participant may receive a telephonic call/ interview from the Organizer during the Contest Period for selection and verification purposes either prior to selection and announcement of each such Participant for next round or during or thereafter. The Organizer will attempt to contact such shortlisted Participant once. In case the shortlisted Participant is not reachable on the number provided or any other means of contact as may be instructed by the Organizer, the Organizer reserves the right to select another Participant as the shortlisted Participant. The shortlisted Participant acknowledges, agrees and understands that receipt of such calls from the Organizer shall not, in any manner, be deemed or considered as any indication that the shortlisted Participant may be selected/ declared for next rounds of this Contest or otherwise and such shortlisted Participant shall not be entitled to make any claims or demands on the Organizer based on the receipt of such calls. Shortlisted Participant will be considered eligible to participate in the audition only when he/she has been specifically declared and intimated by Organizer and not merely because he/she has been contacted by Organizer and/or the Producer or any person claiming to be

representing the Organizer and/or the Producer or any sponsor or associated with this Contest and/or Program. Mere participation in this Contest and sending the Contest Videos does not entitle the Participants to be selected for next rounds and/or win the Contest and the Participants will be selected by the Organizer based on a telephonic or video interview and further terms of each round of selection as per above or such other requirements as may be intimated by the Organizer from time to time. The selection process may vary and shall be as per the Organizer's sole discretion. The Participants or any third party shall have no right to question the process of selection. The Organizer may determine the correctness, quality and validity of each Contest Videos in their sole discretion.

- b) Various rounds of this Audition could be conducted by the Organizer remotely requiring each Participant and selection crew/jury, etc to stay at their respective homes and participate online through any third-party platform as intimated by Organizer from time to time.
- c) The shortlisted Participants as soon as being informed by the Organizer of them being shortlisted for any round of the Contest is required to confirm their participation and availability, in a manner, determined by the Organizer, within 24 (twenty four) hours or such other time frame as intimated by Viacom18, of being informed and confirm the acceptance of participation along with providing requisite details, his/ her personal information, copy of citizenship proof, identity proof, PAN number, address proof, copy of valid passport, etc. and such other details and documents as may be required by the Organizer of the selected Participants.
- d) The shortlisted Participant would also be required to sign a release letter, NOC, and/or a long form agreement or such other related documentations in the format required by the Organizer. Refusal by the shortlisted Participant to execute such documentations in accordance with the Organizer's terms and conditions shall amount to refusal of the selection and the Organizer shall be entitled to choose and declare any other shortlisted Participants.
- e) The Organizer reserves the right to cancel the Contest, remove a shortlisted participants even after announcement of such shortlisted Participants for further participation or as and announce another Participant in place of the originally announced Participants, irrespective of any stage of the Contest, if:
- the documents or details of the Participant are not correct in the opinion of the Organizer; or
- documents so required are incomplete, misleading or untrue; or

- the Participant do not sign the release letter/ NOC/ long form agreement/ forms required, if any, by Organizer; or
- the Participant do not comply with the requirements and instructions of Organizer.
- if the Participant do not approach the Organizer within requisite time frames/ hours of the announcement of selection for next round and/or the Gratification/ Prize;
- If it comes to the notice of the Organizers that the Contest Video/ any other details are not original and/or the Participant has breached the representations and warranties provided herein including infringement of copyright/ non-compliance of third-party platform.
- If the shortlisted participant does not have a valid passport in timelines required by the Organizer.
- viii. In the event the shortlisted participant does not have a valid passport at the time of being selected/ announced as one of the shortlisted participant, they would be required to apply and procure a valid passport on their own and at their sole costs and expense. The Organizer reserves the right to cancel/ remove any shortlisted participant, even after announcement and announce another participant as winner in place of the originally announced participant, if such shortlisted participant fails to obtain a valid passport within required timelines intimated by the Organizer.
- ix. The shortlisted Participant understand and acknowledge that in the event that he/she cannot comply with any of the requirements indicated by the Organizer for any reason, such shortlisted Participants shall not be considered as a eligible and such shortlisted Participants hereby waives all the rights to claim participation or make any other claims against the Organizer with respect to the Contest, Program, leaders/mentors of the Program, and/or Organiser.
- x. The shortlisted Participant understand that this is a one-time opportunity to participate in the further rounds of selection for the Contest. The date, time and other particulars of participation shall be informed by the Organizer from time to time and shall be subject to availability and possibility of all required conditions to conduct said Contest. The shortlisted Participant shall make themselves present at the given time and as per details informed by the Organizer. Inability of any shortlisted Participant to make himself/herself present to for any particular rounds of the audition for the Contest for any reason whatsoever shall result in the disqualification of the shortlisted Participant and disentitlement to further participation, determined at sole discretion of the Organizer. The shortlisted Participant shall have no claims whatsoever against the Organizer for any reason.

xi. The Organizer shall have the right to click photographs, take pictures, shoot audiovisuals, tape, record, mute, delete, edit, exhibit or portray them as the Participants and/or shortlisted Participants and/or publish any content recorded during said auditions of the Contest and exploit it at discretion of Viacom18. By participating in the Contest, the Participants waive all copyrights and any related rights and consents of the Organizer's right to click photographs, take pictures, shoot audio-visuals, tape, record, exhibit or portray them as the Participants/ shortlisted Participants and/or publish any content / Contest Video) submitted by them/ available with the Organizer. The Participants further grant irrevocable consent in perpetuity to use, edit, exhibit, publish, exploit and/or promote the same, in any and all applications including advertising, commercials, promotion, stories, text, illustrations, articles and commercial exploitation, throughout the world, in any and all media, mode or format whether now existing or hereinafter developed, including but not limited to radio, broadcast and television, newspapers, magazines, and electronic media, at any time without the Participants' further knowledge or consent and without any compensation whatsoever.

xii. It is specifically clarified that the shortlisted Participant should not carry, and shall not be entitled to take, any other electronic equipment during into the auditions, including any mobile phones, tablets, laptops, cameras, etc., and/or any other recording devices, other than device from which they are participating. Further, the Participants undertake that they would not do anything knowingly and/or unknowingly leading to disruption of any rounds of audition and take utmost care to ensure there are no virus, trojans or any other aspects corrupting the online rounds during the selection process.

xiii. Further, all shortlisted Participant shall maintain absolute confidentiality with respect to all aspects of the audition, Program, judges/ mentors, selection and next round details, shoot related aspects intimated and/or come to the knowledge of the shortlisted Participant to the release of the same in India. All the shortlisted Participant undertake not to divulge, publicize or disclose any details whatsoever, with respect to the audition/ Program by the shortlisted Participant, to any other person or on any media platform, including on-air, on-print and/or online.

xiv. The Organizer shall have the right, at its sole discretion, to change/ modify/ replace or omit the audition and the shortlisted Participant shall not have the right to claim any damages or monies from the Organizer. By participating in this audition, the shortlisted Participant waive their right to make any such or other claims against the Organizer.

xv. The Organizer takes no responsibility, liability or any other expenses for the shortlisted Participant and does not take any responsibility or liability in case any aspects of audition is cancelled or re-scheduled for any reason whatsoever.

xvi. Notwithstanding anything contained herein, Organizer shall not be responsible to bear or reimburse any costs and expenses incurred by the Participants in availing/participating in the audition and/or incurred otherwise. All such costs/ expenses incurred by the shortlisted Participant in availing/participating in the audition and/or incurred otherwise shall be borne solely by the shortlisted Participant.

xvii. For the purpose of clarification and avoidance of doubt, the selection/ shortlisting does not include any personal expenses of the shortlisted Participant and the shortlisted Participant shall be responsible for any additional expenses/incidental expenses required to be incurred to avail / participate in the audition and/or incurred otherwise.

xviii. The shortlisted Participant hereby represent and warrant that they will comply with all the Rules associated with the Participation including but not limited to the Terms & Conditions mentioned herein and associated with the Contest, and that the shortlisted Participant shall personally be liable for any breach thereto.

7. Gratification/ Prize:

- i. Upon completion of the all rounds of selection for the Contest, if eligible and selected, 1 (one) participant shall be selected and declared as the winner of the Contest ("Winner") and such Winner shall get one-time opportunity to avail below stated gratification, as determined by Viacom18 at its sole discretion and subject to these terms and conditions as applicable ("Prize"/ "Gratification"):
- a) Winner shall get one-time opportunity to be part of the Program crew and travel for 5 (five) days to South Africa where the Program is being shot and recorded and witness the Finale of the Program in person/ live with all the crew, contestant, artist and team, and
- b) Winner shall get one time opportunity to be the digital face of the present season of the Roadies Program and host his/ her own episode review of the present season of the Program on social handles.
- ii. The Prize shall be subject to creative discretion of the Organizer, format of the Program and such rules, regulations and terms and conditions of participation in the Program and execution of a release/ long form agreement as per standard template as might be provided and required by the Organizer. Judges and the Organizer's decision shall be final and binding at all times.

- iii. Gratification involving traveling for 5 (five) days to South Africa will include only cost towards visa, air-tickets, stay in South Africa, transport to and fro and food and beverages costs at the shoot location. These costs shall be borne by the Organsier or the Producer. Organizer shall not be liable for the travel and other related expenses not expressly stated herein, which may be required to be undertaken by the Winner in order to avail/ utilize the Prize and no claims towards same shall be entertained by the Organizers. Further in order to avail this Prize, the Winner needs to have a valid passport, be double vaccinated for Covid19 and follow all protocols issued by government, local authorities, or producer and/or Organiser for Covid19 or otherwise.
- iv. Mere participation in the Contest and sending the Contest Videos does not entitle the Participants to be selected. The selection process may vary and shall be as per the Organizer's sole discretion. The Participants or any third party shall have no right to question the process of selection. The Organizer may determine the correctness, quality and validity of each Contest Videos in their sole discretion.
- v. The Winner understands that this is a one-time opportunity. All particulars of availing the Prize including the longform agreement shall be informed by the Organizer through such mode as deemed appropriate by the Organizer. The Winner shall make themselves present at the location at such time, date, venue as informed by the Organizer. Inability of any Winner to make himself/herself present to avail the Prize for any reason whatsoever shall result in the disqualification of the Winner and disentitlement to the Prize. The Winner shall have no claims whatsoever against the Organizer for any reason.
- vi. The Organizer shall have the right to click photographs, take pictures, shoot audiovisuals, tape, record, exhibit or portray them as the Winner and/or publish any content recorded during the participation and utilization of the Prize and exploit it at discretion of Viacom18. By participating in the Contest and accepting the Prize, the Winner waive all copyrights and any related rights and consents of the Organizer's right to click photographs, take pictures, shoot audio-visuals, tape, record, exhibit or portray them as the Winner and/or publish any content / Contest Video submitted by them. The Winner further grant irrevocable consent in perpetuity to use, edit, exhibit, publish and/or exploit the same, in any and all applications including advertising, commercials, promotion, stories, text, illustrations, articles and commercial exploitation, throughout the world, in any and all media, mode or format whether now existing or hereinafter developed, including but not limited to radio, broadcast and television, newspapers, magazines, and electronic media, at any time without the Winner's further knowledge or consent and without any compensation whatsoever.
- vii. Further, the Winner shall maintain absolute confidentiality with respect to the Contest, various rounds of selection, storyline and contents came to their knowledge

during the Contest and/or utilization of the Prize, audition details, Program, venue, shoot related aspects shown to and/or come to the knowledge of the Winner prior to the release of the same in India. The Winner undertake not to divulge, publicize or disclose any details whatsoever, with respect to the meet and greet by the Winner, to any other person or on any media platform, including on-air, on-print and/or online.

viii. The Organizer shall have the right, at its sole discretion, to change/ modify/ replace or omit the Prize listed above and the Winner shall not have the right to claim any damages or monies from the Organizer. By participating in this Contest, the Winner waive their right to make any such or other claims against the Organizer.

ix. The Organizer takes no responsibility, liability or any other expenses for the Winner and does not take any responsibility or liability in case the Prize and/or Program is cancelled or re-scheduled for any reason whatsoever.

- x. Notwithstanding anything contained herein, Organizer shall not be responsible to bear or reimburse any costs and expenses incurred by the Winner in availing the said Prize and/or incurred otherwise. All such costs / expenses not expressly stated to be borne by the Organizer incurred by the Winner in availing the said Prize and/or incurred otherwise shall be borne solely by the Winner.
- xi. For the purpose of clarification and avoidance of doubt, the Prize does not include any personal expenses of the Winner and the Winner shall be responsible for any additional expenses/incidental expenses required to be incurred to avail the Prize and/or incurred otherwise.
- xii. The Winner hereby represent and warrant that they will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and associated with the Prize, and that the Winner shall personally be liable for any breach thereto.
- xiii. All decisions of Viacom18 shall not be subject to any appeal of any nature whatsoever. Contest Video submissions in the Contest shall be construed that the Participant has waived his/her right to dispute any decision(s) made by Viacom18.
- xiv. Each Participant consents to the use of information supplied by the Participants, to the extent possible under any applicable laws of India, in any media for further promotional, marketing and publicity purposes without any further payment or other compensation to the participant by Viacom18 and its affiliates.
- xv. The Winner/s shall not in any circumstances make any claims against Viacom18 or the Viacom18 affiliates/entities/representatives arising out of or relating to any and all costs, injuries, losses or damages of any kind, including, without limitation due to any technical faults or directly or indirectly, to the winner's participation or non-

participation in the Contest or any related activity. If the Winner is found to be ineligible, or if he or she has not complied with these terms and conditions, the corresponding Submission/s will not be considered further.

xvi. If Viacom18 so elects, Winner/s will be required to submit to a confidential background check to confirm eligibility and may even be required to sign a release letter on the format provided by Viacom18 and help ensure that the Winner/s will not bring Viacom18 Entities into public disrepute, contempt, scandal or ridicule or reflect unfavourably on Viacom18 as determined in their sole discretion.

8. TERMS AND CONDITIONS FOR THE GRATIFICATION

- i. Viacom18 reserves the right to change the Gratification at any time at its discretion.
- ii. The Gratification cannot be transferred, negotiated, refunded or exchanged and only the Winner and not any other person or agent, may claim the Gratification.
- iii. The shortlisted participants/Winner could also be required to sign a release letter or a long form agreement or such other related documentations in the format required by Viacom18. Refusal by the shortlisted participants/Winner to execute such documentations in accordance with Viacom18's terms and conditions shall amount to refusal of selection and Viacom18 shall be entitled to take down or take any other action determined by Viacom18.
- iv. Viacom18 reserves the right to cancel the Contest / take down the Contest Video of the Winner even after announcement and/or publishing of the Contest Video of such Winner, if:
- a) the documents or details of the Winner are not correct in the opinion of Viacom18; or
- b) documents so required are incomplete, misleading or untrue; or
- c) the Winner do not sign the release letter/long form agreement/forms required, if any, by Viacom18; or
- d) the Winner do not comply with the requirements and instructions of Viacom18.
- e) if the Winner do not approach the Organizer within 2 (two) days of being contacted by Viacom18;
- f) If it comes to the notice of Viacom18 that the Contest Video is not original and has breached the representations and warranties provided herein including infringement of copyright.

- 9. The Selected Participants understand and acknowledge that in the event that he/she cannot comply with any of the requirements indicated by Viacom18 for any reason, such Winner shall considered in breach of this Terms and Conditions and such Winner hereby waives all the rights to make any claims against the Organizer with respect to this Contest.
- 10.
