

DANCE DEEWANE Audition (Terms & Condition)

Program and Audition:

Viacom18 Media Private Limited (hereinafter referred to as "Organizer"/ "Viacom18") is producing a television entertainment dance reality show tentatively titled as "Dance Deewane Junior" ("**Program**"/" **Programme**"/ "**Show**") for the purpose of broadcasting in India and /or abroad as required by Viacom18. This Program shall be produced by the third-party production house ('**Producer**') for and on behalf of Viacom18 primarily for the purpose of telecast on **Viacom18's** channel namely "COLORS" ("**Channel**"). The purpose of this Program is to conduct a dance reality series for identifying the best kids with dancing talent in a unique and innovative manner and further as may be developed by Viacom18.

Viacom18/Producer is conducting the auditions for selection of participants for participation in the Program ("**Audition(s)**") and is open for all Indian citizens residing in India, who are of the age group from 4 to 14 years old and the Participants can participate as either as an individual, or as a group (i.e., duo, trio, etc.) (each an "**Applicant**" or a "**Participant**" or "**You**") and the participation shall be governed by the terms and conditions as detailed hereinafter.

For clarity, since the Participants are Minor Participants (as defined below) all the terms and conditions stated herein shall deem to apply on the Parent/Legal Guardian (as defined hereinafter) of the Minor and the Parent /Legal Guardian of the Minor Participant shall be bound by all the terms and conditions on behalf of the Minor at all times.

In case of group participation, each and every Participant within a particular group agrees to comply with these terms and conditions including any other terms in relation to the Auditions, subsequent rounds of Auditions and / or the Program. The Terms and Conditions of and in relation to this Auditions as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This is a legal and binding agreement between the Applicant /Participant (as defined hereinafter) and Viacom18, that states the terms that govern the Participant's participation in the Auditions through the various Participation Mechanisms (as stated hereinbelow) and/or any other platform as communicated hereunder. By clicking on the 'Submit' icon, the Participant agrees to have read and understood the terms and conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the terms and conditions stated herein. These terms and conditions, contained herein shall subsist until the first telecast of the last episode of the Program and /or any such extended duration as may be deemed fit by Viacom18 and hence, the rules shall continue to apply on the Participants.

Participation mechanism:

The Participant can participate in the Auditions in the following manner:

Participation through Voot App and/or Voot Website and/or My Jio App: By visiting the website www.voot.com ("Website") or by downloading the Voot mobile application as

owned by Viacom18 (“**Voot App**”) or by downloading the MyJio App on Your mobile device and filling in the online form asking for relevant details of the Participants including, inter alia, a) Name of the Participant / Name of Parent / Legal Guardian; Relation with Minor Participant (in case of Minor Participants), b) Age, c) Address, d) Nationality, e) email id, f) Contact number (mobile /landline), (g) City, etc. and uploading the Audition Video. For Participants who are **Minors** (as defined below), additional mandatory details regarding Participant’s guardian and their relationship needs to be provided. In case of Group participation, if any as per the format / structure of the Program, all the member Participants belonging to their respective groups shall provide all the details as required to be mentioned, including the name of the group and total number of Participants participating in the group.

Participation through Email Mechanism:

Participants can also participate in the Auditions by sending an email containing their details as provided under clause 2(i)(a) above along with the Audition Video at DDKids@colorstv.com (“**Email ID**”). The Viacom18/representative of Viacom18/Producer may get in touch with the Participant and/or his/her Parent/Legal Guardian for obtaining the other details required for furthering the Audition purposes if so determined by Viacom18.

The Participation through Voot App and/or Voot Website and/or MyJio App and participation through Email Mechanism and/or any other platform as communicated herein shall collectively be referred to as 'Participation Mechanisms'.

The Participant's participation in the Auditions shall only be considered as valid only upon the Participant's submission of all the details as required AND upon submission of the Audition Video as per the terms and criteria laid down herein and/or as informed by Viacom18 /authorized representative of Viacom18 through phone calls, sms, emails conversations, meetings and/ or in any other manner whatsoever. The Auditions / subsequent rounds of auditions may be conducted at the sole discretion of Viacom18 in a few cities across India (as solely decided by Viacom18) and all the terms and conditions stated herein along with any other terms, rules and regulations as applicable for such auditions shall deem to be applicable and binding on all the Participants / participants/contestants. The Participants undertake to sign all documents / forms / release letters/ declaration / consent letters, etc as may be required by Viacom18 from to time in relation to the Auditions and the Program.

Upon submitting the required information to Viacom18 in any of the manner as provided hereinabove (including but not limited to the submission of the Audition Video and recent photographs through any of the Participation Mechanisms and/or otherwise) in accordance with

the requirements and criteria as laid down for the Auditions herein, the Participant and/or his/her Parent/Legal Guardian (as the case may be) hereby agree to have read and understood all the terms and conditions for participation in the Auditions and agree to abide by the same. In case of group participation, if applicable, Viacom18/ Producer at their sole discretion may choose not to select the entire group but only the best performers within the group to further participate in the Audition/ subsequent rounds of audition / Program. You hereby agree, undertake and acknowledge that there is no documentation/ undertaking signed/ confirmed by You in the past which contradicts or is in conflict with the aforesaid condition. Further, in case of group/ duet participation even if one of the Participants within a group fails to comply with any of these terms and conditions and/or Rules, then Viacom18 / Producer may, at their sole discretion disqualify such entire group/ particular Participant within a group, at any point of time, from further participation, without any liability to any other member Participants within such group. The Participants within a group shall not have any right to raise any claim / objection against Viacom18/Producer's decision to disqualify / reject the entry of such group/ Participant(s) within a group at anytime and all terms and conditions contained hereunder shall be deemed to apply to each Participant within a group.

Eligibility Criteria:

Participants of minimum 4 (Four) years of age till 14 (Fourteen) years of age and above are eligible to participate

in this Audition and the Program (if selected thereafter). However, Viacom18 may at any time and as per its sole discretion, impose age limit/restriction of the Participants who would be eligible to participate in the Audition, subsequent rounds of Audition and the Program (if selected thereafter).

The following additional requirements shall be applicable:

all the details as required to be provided to Viacom18 (including but not limited to as may be required to filled in as displayed on Voot App / Voot Website / My Jio App/ Email Mechanism) must be duly filled in by Your parent or legal guardian on Your behalf. The parent or legal guardian of the Minor participating in the Auditions (**'Parent' / 'Legal Guardian'**) shall be bound by all the terms and conditions as stated herein including without limitation any and all terms as may be laid down / communicated by Viacom18 in relation to the Auditions and the Program. Further that, the Parent/Legal Guardian on behalf of the Minor hereby represents and undertakes that all personal details and/or information submitted to Viacom18 through any of the Participation Mechanisms including without limitation through phone calls, emails, personal meeting and/or in any other manner whatsoever are true, accurate, complete and in no way misleading /incorrect and/or incomplete. Additionally, the Parent/Legal Guardian on behalf of the Minor may be

subsequently required to, also sign and submit all such necessary documents/ release letters / declaration letters/ no objection letters/ certificates/ agreements, etc., as required by Viacom18 and/or the Producer and/or its authorized representatives from time to time, in relation to the Auditions and/or for participating in the Program (if selected) and/or otherwise, either with Viacom18 directly or any other party, as Viacom18 may require at any time.

If You are selected for the subsequent round of audition/ venue audition (as the case may be), You must be accompanied by Your Parent or Legal Guardian during such audition and (if applicable) subsequent shoots, rehearsals, etc in relation to the audition and the Program at all times;

Viacom18 shall have the authority and right to disqualify You, at any point of time, if it comes to Viacom18's knowledge that You, being a Minor have participated without the due consent, knowledge and awareness of Your Parent or Legal Guardian and/or You are in breach of any terms and conditions and/or undertakings herein;

The Parent or Legal Guardian of the Minor participating in this Audition hereby represents and confirms that such Parent or Legal Guardian completely understands the nature of the Program and that he /she has voluntarily chosen at his /her free-will to permit his / her Minor child to participate in the Audition and

further participate in the Program (if selected) and such Parent or Legal Guardian is willing to bear all risks, costs & consequences arising from participation of his / her Minor child in the Audition and/or the Program. All the representation and warranties, obligations, terms and covenants as laid down herein and applicable to the Minor child participant shall be deemed to be applicable on the Parent / Legal Guardian and the Parent / Legal Guardian hereby agrees to comply and abide by the same;

The Parent / Legal Guardian hereby agrees and acknowledges that it shall be such Parent's / Legal Guardian's complete responsibility to ensure that the Minor's school/college/university/institute's attendance and education is not affected due to his / her Minor child's participation in the Audition/ subsequent auditions and/or the Program (if selected). The Parent/Legal Guardian hereby undertakes to be fully responsible towards the Minor Participant's education and shall ensure that the Minor Child's education and welfare will not be affected in any manner while permitting him/her to participate in the Auditions, subsequent round of auditions and / or the Program.

in case of group participation all the terms and conditions as mentioned herein are required to be followed by each member of the group.

Audition Period:

(i) Registration / participation through Email Mechanism: The 'Audition Period' shall commence from 20 January 2022 and shall tentatively conclude on 30 March 2022 or such other date and time as decided and updated by Viacom18, as per its sole discretion "Closing hours".

(ii) Registration / participation through Voot App and/or Voot Website/MyJio App: The Audition Period shall commence from 20 January 2022, and shall tentatively conclude on 30 March 2022, or such other date as may be decided and updated by Viacom18 and/or modified at the sole discretion of Viacom18 and the same shall be updated on Voot or Voot Website MyJio App and/or shall be informed by Viacom18 in any other manner as it deems fit. It shall be the responsibility of the Participants to keep themselves updated with respect to any change/modification in the terms and conditions and/or as informed by Viacom18 and any such modification shall apply to all the Participants and the Participants shall be bound by the amended / modified terms and conditions. The Audition Period depending on the Participation Mechanism shall be construed accordingly.

Requirements of the Audition Video:

The Audition Video should contain a dance video as performed and recorded by the Participant. The Participants shall be solely responsible and liable at his / her sole costs for the song/music as used and synchronized by the Participant in its Audition Video.

Duration of the Audition Video: The Participant shall ensure that the maximum duration of the Audition Video shall be 3 (three) minutes and any Audition Video exceeding the aforesaid criteria shall be rejected.

Size of the Audition Video: The maximum permitted size of the Audition Video can be 50 MB.

Technical Specifications: The Audition Video file can be uploaded by the Participant in the following formats: avi, mov, mp4 or any other regular video format.

Number of times the Audition Video can be sent / uploaded: The Participant may upload and/or submit his/her Audition Video through any of the Participation Mechanisms, multiple number of times before the Closing hours of the Audition Period.

Viacom18 at its sole discretion may either select the Audition Video as submitted on either of the Participation Mechanisms by the same Participant as an entry for the purpose of Audition and subsequent selection.

Documentation and Proofs:

You and/or Your Parent/Legal Guardian (as applicable) confirms that You are a citizen of India and You shall submit, at Viacom18's request valid (i) government issued identity proof (viz. Driving license; Permanent Account Number ('PAN'); Aadhar Card; Voters identity card, Passport number, etc.), including valid proofs of age, nationality / citizenship [i.e. birth certificate and/or /PAN Card / Aadhar Card, valid passport, VISA (as the case may be)etc.]; (ii) residence proof; (iii) any other document as may be required for participation in the Program, in consonance with the laws of India and/or any other documents as may be required by Viacom18/Producer from time to time. Further in case of Minor, all the documents along with valid identity, age documents and other documents (as required) substantiating the relationship between such Minor and his/her Parent/ Legal Guardian, who shall be signing /uploading / sending the application form subsequently on behalf of the

Minor shall also be provided, to the satisfaction of the Producer / Viacom18. You and/or Your Parent/Legal Guardian (as applicable) hereby represent and undertake that all personal details and/or information given by You and/or Your Parent/Legal Guardian in the online form /as submitted through any of the Participation Mechanisms and/or in any other manner as intimated to You and/or Your Parent/Legal Guardian by Viacom18/ representative of Viacom18/Producer are true, accurate, complete and in no way misleading or incorrect or incomplete. Further that, Viacom18 shall have the sole and unfettered right/authority (at its discretion) to disqualify any Participant from Auditions and/or participation in the Program (at any point) if the Participant and/or his/her Parent/Legal Guardian (as applicable) fails to comply with any of the terms and conditions stated herein. Additionally, the Participant and/or his/her Parent/Legal Guardian (as applicable) shall also sign and submit all such necessary documents/ release letters/ declaration letters/ no objection letters/certificates/ agreements etc., as required by Viacom18 and/or the Producer and/or its authorized representatives from time to time, in relation to the Auditions, subsequent audition and/or for participating in the Program (if selected) and/or otherwise either with Viacom18 directly or any other party, as Viacom18 may require at any time and the aforesaid additional documents and these terms and conditions shall be read in consonance with each other.

By submitting the information and the Audition Video through any of the Participation Mechanisms, and/or through emails, sms, phone calls, documents and /or otherwise, You and/or Your Parent/Legal Guardian (as applicable) hereby waive all privacy rights and/or any other

rights including but not limited to proprietary rights, copyrights, etc. and/or any privacy expectations that You and/or Parent/Legal Guardian (as applicable) may have with respect to the use of the information furnished by You and/or Parent/Legal Guardian (as applicable) in any manner. Viacom18 / Producer may use the information for sending out commercial information and/or for other commercial, publicity or promotional purposes and the Participant and/or his/her Parent/Legal Guardian (as applicable) shall not raise any objection against the same.

In case of group participation all the terms and conditions as mentioned herein in clauses (i) to (ii) are required to be provided for each member of the group.

Term:

These terms and conditions, all Rules (as defined hereinafter) contained herein shall subsist until the first telecast of the last episode of the Program and /or any such extended duration as may be deemed fit by Viacom18 and hence, the Rules shall continue to apply to the Participant and/or his/her Parent/Legal Guardian (as applicable).

Content/Recording:

All the Audition Videos, audio visual recordings, audio / video clips, performance executed (including audio, video, audio-visual, etc.), musical recordings (audio and video), content, materials, audio / video clips, bytes, etc. provided/ uploaded/ submitted and/or uploaded by the Participants through any of the participation Mechanisms and/or through emails and/or otherwise ('Content') shall upon creation / submission become the property of Viacom18 and accordingly all intellectual property rights including copyrights as per the Copyright Act, 1957 and/or any other

equivalent provision thereof under applicable laws in the Content shall vest with Viacom18 and Viacom18 shall have unfettered exploitation rights in and to the Content, through any and all modes, medium, formats, platforms of exploitation, throughout the world in perpetuity.

You and/or Parent/Legal Guardian (as applicable) expressly agree to your subsequent audition and participation at any stage including in the Program (if selected) being recorded and telecast as a part of the Program and/or for promotion of the Program and/or on a stand-alone basis, as required by Viacom18 (“**Recording**”). You and/or Parent/Legal Guardian (as applicable) hereby grant to the Channel and Viacom18/its affiliates/group companies etc., the unfettered right to exploit exclusively and in perpetuity, throughout the world, the Content and /or Recording, and its derivatives thereof and/ or any part thereof, through any and all means including but not limited to the right to use Your and Your Parent /Legal Guardian’s name including sobriquet, photographs, images, likeness, voice, audio –visual / videos, Audition Videos Content, Recording, etc. provided/ submitted by You and/or Your Parent/Legal Guardian (as applicable) to Viacom18 and/or recorded by Viacom18 / Producer during the Auditions/ subsequent auditions / Program through all media including without limitation television, radio, print, mobile, internet, websites, mobile applications and/or any other such media, technology in existence, whether now known and/or devised in the future, from time to time, for unlimited transmission in perpetuity for the territory of entire world, as the Channel/Viacom18, may deem fit. Viacom18/Producer shall not be obliged to exploit the Content /Recording (if made), into the final version of the Program. You and/or Parent/Legal Guardian (as applicable)

agree that on submission/creation of the Content, all intellectual property rights including copyrights in the Content/Recording shall vest with Viacom18 and shall be available to Viacom18 for exploitation throughout the world in perpetuity. You and/or Parent/Legal Guardian (as applicable) hereby agree that Viacom18 shall have complete, unfettered and exclusive exploitation rights in and to the Content /Recording and have all the rights to exploit, edit, integrate other content with Content/Recording, distribute, exhibit, sell, transfer, license, sub-license, monetize and exploit the Content/Recording on various platforms and through various format, modes, media including but not limited to satellite, internet, digital, cable, wireless networks (Wireless LANs, WIFI, Broadband) WAP, imode any other modes of wired or wireless distribution or exploitation via radio frequencies etc. whether circuit switched or packet switched. These shall include linear transmission or re-transmission of Content /Recording via terrestrial, satellite television, MMDS, SMATV, DTH, IPTV, HITS, SSL, XDSL, DBS, cable television, mobile technologies, internet etc. streaming through internet / broadband / IPTV/ WAP/ iMode / other Mobile Technologies, digital TV (including DBV-H, DBV-T etc.), all forms of on demand (SVOD, TVOD, AVOD, NVOD, PPV etc.) whether free or pay & shall include Free TV & Pay TV and shall also include all forms of non-linear transmission/exploitation including through web, internet, IPTV, mobile, applications, etc. Interactive multimedia, clips, Home Video Rental & Sell Through (including DVD, Compact Disc, Laser Disc, Blue Ray Discs, Video Compact Disc, Video Cassette, Videograms, embodying in any manner in any storage medium, VHS and such other rights), Download to Own, Download to Rent, commercial video, Internet multimedia,

communication to public within aircrafts, Railways, Ships, boats, vessels, surface transport and hotel and commercial establishment rights and also include modes, media, formats, platforms of exploitation: (i) in existence now, (ii) in existence now but not in commercial use on the date of execution hereof, and (iii) as may be developed in future.

You, Your Parent / Legal Guardian do not and shall not have any right to receive or claim any remuneration / compensation, fees at any time whatsoever, towards the usage / exploitation of the Content /Recording by Viacom18 and /or any party authorized by Viacom18 and further You and/or Parent/Legal Guardian (as applicable) hereby irrevocably grant and assign to Viacom18, free and clear of any and all claims, all of the rights and interests in such Content/Recording exclusively and in perpetuity, throughout the world, and in all media, now or later known or devised including in commercial use.

Rules:

In the event of large number of registrations, participation, the chance to be considered for Auditions, subsequent auditions may be strictly on submission of the Audition Video through any of the Participation Mechanisms on the first come first basis till closure of the Audition Closing hours. You and/or Your Parent/Legal Guardian (as applicable) acknowledge, agree and undertake to abide at all times by all the rules, regulations, terms and conditions for this Auditions as laid down herein and as determined from time to time by Viacom18 (the "**Rules**"). You and/or Your Parent/Legal Guardian (as applicable) agree and acknowledge that the Rules, may be changed at any time by Viacom18 including but not limited to cancelling or postponing the Auditions and/or the Program and/or

introducing new / subsequent rounds/levels and/or changing the format of the Auditions and/or the Program and/or introducing wild card rounds of Auditions / subsequent rounds of Auditions and /or in the Program and / or otherwise and You will be bound by such altered / changed /new Rules/new terms and conditions. You and/or Your Parent/Legal Guardian (as applicable) shall be responsible to make themselves aware about the altered / modified Rules / term and conditions and shall continue to be bound by the same and Viacom18's decisions shall be final in matters concerning the same. Viacom18 may at its discretion provide a chance for entry to the Auditions for unregistered people also including but not limited to a foreign nationals provided all the terms and conditions are duly complied with. You and/or Your Parent/Legal Guardian (as applicable) will not raise any claim or dispute due to such change and nor shall Viacom18 be liable to bring the same to your notice or attention. In case the Participant is selected for the subsequent audition / venue audition, then the Participant and/or his/her Parent/Legal Guardian (as applicable) agrees to maintain the decorum of the Audition venue and fill the requisite audition form/application form as required by the Producer or Viacom18 and the terms and conditions contained herein and such additional audition form / application form shall govern the Participant's participation in the subsequent rounds of audition and the Program (if selected). Further the instructions of the Producer shall be adhered to strictly. Any Applicant/ Participant and/or his/her Parent/Legal Guardian (as the case may be) who acts in contravention to the instructions of Viacom18/Producer or is found creating nuisance either to Viacom18/Producer or the other Participants shall immediately be disqualified from participating in the

subsequent audition / venue audition. You and/or Your Parent/Legal Guardian (as applicable) agree that only the final shortlisted Participants will be contacted directly by Viacom18's representatives for every subsequent round of audition and selection in the Program and Viacom18/Producer shall not entertain any correspondence by any Participant/person /party in this matter at any time. In case of group participation, even if one of the Participants fails to comply with any of these terms and conditions and/or Rules, then Viacom18 / Producer may, at its sole discretion disqualify such group at any point of time, from further participation in the Audition/subsequent rounds of audition / Program, without any liability to any member Participant within such group. The Participants and/or their respective Parents/Legal Guardians within a group shall not have any right to raise any claim / objection against Viacom18/Producer's decision to disqualify / reject the entry of such group at any time. The Participant and/or his/her Parent/Legal Guardian (as applicable) shall comply with all the applicable laws of India and /or any other applicable laws, rules and regulations in relation to the Participant's act/participation/performance in the Auditions and/or the Program and shall solely be responsible for the same at all times.

Other Terms:

You and/or Your Parent/Legal Guardian (as applicable) hereby confirm that You are medically, physically and mentally fit and sound and that You do not have any kind of medical/physical/mental/emotional condition (including without limitation any heart ailment, blood pressure, final stages of pregnancy and/or psychological, anxiety, hypertension, depression, disease / disorder and/or any

other medical problems of any kind whatsoever, etc.) which can jeopardize Your eligibility for participation in the Audition and /or which may affect /cause any nuisance to fellow Participants in Auditions/subsequent rounds of audition and/or Program (if selected). If at any point in time, it comes to Viacom18's knowledge that You are/ have become medically / mentally/ physical unfit to continue with Your participation in the Auditions/subsequent rounds of audition / Program, then Viacom18/Producer reserves all rights to disqualify / eliminate You from the next round of audition / Program (if you have been selected) and/or at any point in time, without any liability to You and/or Your Parent/Legal Guardian (as applicable). Viacom18/Producer reserves the right to include without limitation any additional round /level, theme / feature such as a wild card entry, viewer's choice, public demand, etc. in the Auditions, any subsequent audition process, and/or between any round/phase of the Audition, subsequent audition including introducing any wild card entry in the Program that may include any person as a wild card entrant/participant in the Audition / Program at any time during any stage of the Program. Viacom18 reserves all rights to increase or decrease the number of rounds/ levels of the Auditions/ subsequent rounds of audition at anytime at its sole discretion and You and/or Your Parent/Legal Guardian (as applicable) shall not have any right to object against the same and any such changes shall be deemed to be binding on all the Applicants / Participants.

If for any reason the Auditions is not capable of being executed as planned, due to, including without limitation infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, on any of the Participation Mechanisms and/or due to any other causes

which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Auditions, Viacom18 reserves the right, at its sole discretion, to disqualify any Participant who may be responsible or who tampers with the entry /Auditions process, and to cancel, modify or terminate the Audition or any part of the Audition/Program. Further, Viacom18 reserves the right to take legal action against such Participant/Parent/Legal Guardian/person /party who has committed a breach under the Cyber laws (Information Technology Act, 2000 and all its amendments thereof) and/or any other laws as may be applicable from time to time and Viacom18 shall be entitled to such remedies in law as applicable.

Viacom18 shall not be held responsible in case of a server shutdown or loss of Participant's Audition Video / data.

The Participant and/or his/her Parent/Legal Guardian (as applicable) agrees that they shall be charged for internet usage / mobile data usage at such rates as levied by its internet service provider / mobile service provider and the same shall be checked and shall be borne by the Participant and/or his/her Parent/Legal Guardian at their sole responsibility.

Viacom18 shall not be responsible for any delay in receipt or non-receipt or incomplete receipt of the Audition Video / other details of the Participant. Viacom18 shall not be responsible for any technical difficulties or data corruption that may arise during recording/upload of the Audition Video/content. Further, Viacom18 shall not be responsible and/or liable in any manner whatsoever in case the Participants are unable to register their entry and participate in the Auditions due to failure on part of the internet service

provider, facility provider, etc. Shortlisted entries, as selected by Viacom18 shall only be intimated as per the contact details provided on any of the Participation Mechanisms and/ or in any other manner as deemed fit by Viacom18/representative of Viacom18/Producer.
